

"Conditions of Carriage for Bit Air E-Tickets"

1. General Provisions:

- This document constitutes the contract of carriage between Bit Air (hereinafter referred to as "the Carrier") and the passenger (hereinafter referred to as "the Passenger").
- The Carrier reserves the right to refuse carriage to any Passenger who does not comply with these conditions.

2. Ticket Information:

- The e-ticket issued by Bit Air includes the itinerary receipt, electronic coupons, and any boarding document provided to the Passenger.
- The Passenger must present the e-ticket and a valid ID at check-in and boarding.

3. Check-In and Boarding:

- Passengers must complete check-in and receive their boarding pass by the specified deadline.
- Boarding is subject to the Carrier's discretion and may be refused if the Passenger fails to comply with check-in procedures.

4. Baggage:

- Passengers are allowed a certain amount of free baggage, subject to size and weight restrictions.
- Excess baggage will be subject to additional charges.
- The Carrier is not liable for loss or damage to unchecked baggage.

5. Refunds:

- Refunds are subject to the Carrier's discretion and may be denied if the Passenger cancels the ticket after the specified deadline.
- Refunds will be issued in the same form as the payment was made.

6. Liability:

- The Carrier's liability for death or bodily injury is unlimited.
- For loss, damage, or delay to baggage, the liability is limited to 1,131 Special Drawing Rights (approximately EUR 1,200; US \$1,800) per passenger.
- For delay to the journey, the liability is limited to 4,694 Special Drawing Rights (approximately EUR 5,000; US \$7,500) per passenger.

7. Cancellation and Delays:

- The Carrier may cancel or delay flights due to unforeseen circumstances.
- Passengers will be notified of any changes and may be entitled to refunds or alternative arrangements.

8. Conduct Aboard Aircraft:

- Passengers must comply with all safety and conduct regulations while on board.
- The use of electronic devices is subject to the Carrier's policies.

9. Successive Carriers:

- If the journey involves multiple carriers, the terms and conditions of each carrier will apply to their respective segments.

10. Governing Law:

- This contract is governed by the laws of [Country/State].
